

# Terms and Conditions

Terms of conditions and use and membership agreement for use of **www.griffinchat.com** (the site) and service providers **griffinchat.com** (service provider) who provide psychic instant and text messaging. These general terms apply to all users of the site and members:

Use of the site is on the basis these terms and conditions are accepted by accessing and using the site. If you do not agree with the terms and conditions please do not use the site or the services provided.

- a. You confirm that you are over 18 years of age and are of sound mind.
